To register for a competition, you must sign up as a team. Therefore, you should form your group prior to the sign-up period.

If you don't have a team and wish to be matched with one, the competition coordinators will open up matching applications before the sign-up day.

WITNESS EXAMINATION

Witness Examination is a **simulated criminal trial** that allows you to pair up with a partner and assume the roles of a barrister and a witness. Together, you will develop a case theory based on witness testimonies and reveal facts during intense examination sessions. This competition, ranging from conducting an examination-in-chief to performing a crossexamination, provides a great opportunity to refine your legal skills and understanding of trial procedures.



INTERNATIONAL HUMANITARIAN LAW MOOT

In the International Humanitarian Law (IHL) moot participants research and present arguments on topics related to armed conflicts and international crime. **Teams act as the Prosecution or the Defence in a mock International Criminal Court (ICC)** scenario, focusing on the protection of civilians and regulation of warfare methods. It's an opportunity to advocate for important legal and moral issues, such as war crimes and human rights abuses.

Competition Information

- Open to all students!
- The only competition focused on international law.
- Uses the same problem question for the entire competition.
- Approximately two days of work required for the first round.
- In subsequent rounds, participants mainly concentrate on refining their arguments, significantly reducing the time commitment compared to the first round.

The Client Interview Competition is a simulated scenario in which a team of two students conducts a mock interview with a client (an actor) on a legal claim. The objective is to skilfully ask questions, listen attentively to the client's concerns, discern the facts. uncover accurately hidden information, and evaluate the merits of their case. With clients varying in demeanour - from being talkative to reserved, emotional, angry, or even deceptive, the competition serves as a unique platform to refine your people skills.

Competition Information

- There is NO preparation required.
- Each round is under 30 minutes (15 min interview, 2 min discussion, 5 min briefing, then some feedback).
- You receive a short memo before the competition to inform you who the client is and give you an idea of their legal issue.



I'm nervous about public speaking. What can I do?

Don't worry, internal competitions are the perfect place to practice and improve your public speaking skills. In the initial rounds, only your team and the judges will be present, which reduces the pressure. The amount of public speaking varies per competition with some, like Negotiations and Client Interview, being more conversational. In Mooting, roles are divided within the team, with barristers presenting to a small panel of JD student judges, and instructing solicitors contributing through research and formulating submissions.



Do I have to sign up as part of a team?

Yes, team sign-up is required for all competitions. If you're keen to participate but don't have a team yet, we've got you covered! <u>Each competition provides a team-matching process before sign-ups start</u>. Stay updated with our Facebook page for information on when team matching forms become available!



What if I'm concerned about the time commitment?

All competitions are team-oriented, so you'll have support when things get hectic. Some competitions, like the Client Interview, require minimal preparation time. Plus, competitions like First-year Mooting align with your class content, allowing you to simultaneously study and enhance your class knowledge while competing.



Is prior experience required to participate?

Absolutely not! Our internal competitions are designed for participants of all experience levels.

HOW TO SIGN UP FOR AN EXTERNAL COMPETITION

SIGN UP TO COMPETE

For most external competitions, Melbourne Law School will only have 1-2 teams of 3 people. As the team will be representing Melbourne Law School in competitions held in Victoria, interstate, and overseas, all external competitions (with the exception of the Essay Competition) involve a selection process. All registration fees are covered by the MULSS.

Applications for each external competition will open prior to each competition. The relevant dates for registration for events hosted by MULSS are listed in this document (where available). For competitions hosted by other universities and law societies, these dates will be confirmed throughout the year.

All sign-up forms will be posted on the <u>MULSS Competitions</u> Facebook page and the <u>MULSS website.</u>

Except for the Essay Competition (and unless otherwise stated), you must register for each competition as a team. Therefore, you should form your group prior to the close of registrations for each competition.

If you don't have a team and wish to be matched with others, the external competitions portfolio will (generally) open up matching applications during the registration period. This does not guarantee selection.

SIGN UP AS A TIMEKEEPER

To assist the judges with the running of the Parliamentary Debate and the Sir Harry Gibbs Constitutional Law Moot, applications will be sought from JD students to keep time.

Timekeepers are only expected to participate in 1-2 rounds per competition with all instructions and guidance provided in advance.

Applications for timekeepers will open during the registration period for the relevant competitions. The application forms will be posted on the MULSS Competitions Facebook page and the MULSS website.

HOSTED BY MULSS

External competitions are divided between those hosted by MULSS and those hosted by other law schools and law student societies. All involve students from Australian universities (and sometimes international universities) competing against each other. They are a great way to gain exposure to law students at other law schools, legal professionals, judges, academics, and others. This year, the External Competitions portfolio plans to host four competitions.

PARLIAMENTARY DEBATE

The Parliamentary Debate returns this year after a break during COVID. With a large number of JD students having studied, worked in, or being interested in politics, this competition provides a forum for students to debate important legal and legal-related topics in a parliamentary debate format. If you prefer making oral arguments rather than producing written submissions, this competition is for you!

Competition Information

- Open to all JD students.
- Teams of 3 students.
- Parliamentary debate format with affirmative and negative teams.
- The topic will be released 24 hours prior to the round robin and teams notified of their position (affirmative or negative) 30 minutes prior to their round.
- The top teams will progress to the finals.
- A great opportunity to improve your debating skills!

FREQUENTLY ASKED QUESTIONS

Do I have to sign up as part of a team?

Except for the Essay Competition (and where otherwise stated), yes, team sign-up is required for all external competitions. If you're keen to participate but don't have a team, <u>each competition will (generally) have a team-matching process during the registration period.</u> Stay updated with our MULSS Competitions Facebook page for information on when team matching forms become available!



Is prior experience required to compete?

With the exception of the Sir Harry Gibbs Constitutional Law Moot (which requires students to have completed LAWS50028 Constitutional Law) and unless otherwise stated, all JD students are able to apply to compete on behalf of Melbourne Law School in external competitions. Please note, however, that eligibility to apply does not guarantee selection.



How are teams selected?

As most external competitions only permit 1 or 2 teams per university to compete, where the number of applications exceeds the number of places available, a competitive selection process will be run jointly by the MULSS and Melbourne Law School faculty representatives. Students will be selected based on their academic, professional, and/or competition experience. Students will be afforded the opportunity in their applications to outline their experience and provide a statement about why they have applied to the competition and what they hope to achieve by competing. We encourage all interested students to apply!



Do I need to be a JD student to compete?

For all MULSS-hosted external competitions you must be studying the Juris Doctor (JD) at Melbourne Law School (unless otherwise stated). For externallyrun external competitions, Melbourne Law Masters (MLM) students will only be permitted to compete if the competition organiser permits MLM students to participate.
